We rely on generous volunteers like you to assist us in fulfilling our mission of bringing about the best possible treatment and quality of life for all animals in Wood County.

By making a formal application to serve on The WCHS Board of Directors, you also make certain specific commitments for the duration of your Board service. Of foremost importance, a Board of Directors has certain legal obligations, known as duties, to the organization that it serves. These duties include:

- Take reasonable care when making decisions for the organization (called "duty of care")
- Act in the best interest of the organization (called "duty of loyalty")
- Act in accordance with the organization's mission (called "duty of obedience")
- Stand aside when you have a conflict of interest (called "recusal")

In addition to these duties, all Board members commit to the following:

- 1. I will represent The WCHS's work and values to the community and promote the organization.
- 2. I will attend at minimum 75% of Board meetings (held monthly at 6:30 p.m. on the third Wednesday) and special events.
- 3. I will maintain annual membership in The WCHS.
- 4. I will take seriously the legal responsibilities of serving on The WCHS Board of Directors, including and especially the fiduciary role.
- 5. I will stay informed about what is going on in the organization. I will ask questions and request information. I will participate in and take responsibility for making decisions on issues, policies, and other Board-related matters.
- 6. I will work in good faith with staff and other Board members as partners towards achieving our goals, treating the staff and other Board members with professionalism and respect.
